Of the Dalys, I mostly look at the christian names Joseph, Charles, Daniel, Richard, James (though most of these are from Galway), Edmond, or where the grantee is someone who does business with the Dalys, e.g. Clanchy, Lyons, Callaghan, Langford, O'Donnell, Costley. Also Gawley (alternate form of Dalaigh). The deeds can be very hard to read (at least for me) and there are likely many errors in the notes here. The idea is to provide an index. If you see interesting notes, I encourage you to go to the registry of deeds and see the original memorial yourself.
